#### **Teamwork Makes the Green Work!**

2024 was another very busy, and overall, successful year! We served 15,909 individuals – a new service level record! You will find examples of "mission moments" on the following pages. The annualized value of the wages for the 560 individuals placed in employment last year was \$12.14 million. Those payroll dollars strengthened individuals, families and communities.

In 2002, John Maxwell wrote a book entitled "Teamwork Makes the Dream Work" and a new catch phrase was born. Being part of a team that helps individuals prepare for, find and retain employment is a key cultural component of our agency. As team members, we try to thread that mission into everything that we do. In our Donated Goods Retail Operation, there's always a great deal going on behind our sixteen store fronts, and in 2024, the focus on using every possible bit of treasure that donors so graciously granted shifted to a whole new level. As you will see in the next few pages, the agency moved ever closer to its dream of being a zero-waste organization. The Goodwill team is proud of this effort to be as "green" as possible, to support reuse or recycling wherever possible and to practice sustainability from both a natural resource and a fiscal stability perspective. This is a journey that has miles behind it and miles to go before it concludes. Please watch for our progress as we head into our 98th year of serving Ohio's Summit, Portage, Medina, Ashland and Richland Counties!

Speaking of journeys, during 2024, Goodwill continued to operationalize \$3 million of MacKenzie Scott's 2020 \$5 million grant through a dedicated revolving automobile loan or repair fund. This fund's objective is to help permanently decrease transportation barriers in its five-county territory through a mechanism that can be sustained by reloaning the repayments of any original loans. Several loans were backed this past year, and the agency is searching for financial servicers in all five of its service counties. In the meantime, it continues alleviating short-term transportation barriers using the remainder of its Scott grant. This past year, over 4,400 individuals and families accessed \$320,000 in bus passes and fuel cards!

In addition to all the important historic job training and placement services Goodwill provides, the agency's Elizabeth Clark Emergency Fund supports those in our communities needing a short-term "hand up". In 2024, more than 3,300 individuals and families procured \$211,000 in goods from our stores through the crisis cards. Our retail customers' support for Round Up provided \$118,000 of the card's funding. Many of these crisis cards, as well as bus passes and fuel cards, are accessed through Goodwill's partnerships with fellow community agencies in the five-county territory. In short, community teamwork makes our program participants' dreams work!

Thank you for your past and future support! Please continue to follow Goodwill's journey toward its green sustainability milestones and its quest to reduce transportation barriers. Goodwill's team is excited to be supporting dreams and facilitating opportunities to strengthen lives and communities through the power of work!

# Going Green:

## **Goodwill's Commitment to Sustainability**

At Goodwill Industries of Akron, sustainability drives our mission. Through innovative recycling programs and eco-friendly initiatives, we're creating a greener future for our community.

#### 2023: Laying the Foundation for a Greener Future

- **Single-Stream Recycling:** Goodwill partnered with Waste Management to simplify recycling materials in one bin at retail locations and offices.
- Cardboard Recycling Boost: The agency expanded efforts to recycle more cardboard, reducing waste and improving efficiency.

#### 2024: Expanding Our Impact

- Plastic Bag Phase-Out: In an effort to reduce plastic waste, Goodwill's retail locations halted plastic bag distribution on Earth Day 2024, offering reusable options and donated boxes/bags at no cost.
- Glass Recycling: Through a partnership with Waste Management, the agency recycles clear and colored glass after it goes through the entire donation stream and Outlet store.
- Zero-Waste Goal: Goodwill made strides toward Zero-Waste certification, with plans to expand paper recycling in 2025.

#### By the Numbers: 2024 Impact

- 374,326 donors helped fuel our mission.
- 35.5 million pounds (17,780 tons) of donated goods processed.
- 92,894 pounds (46.5 tons) of computer equipment recycled through Dell Reconnect.
- 7.58 million pounds (3,790 tons) of materials recycled and repurposed through salvage, including plastic, cardboard and glass.
- 12,005 tons (68%) of donated goods sold in stores.
- **3,790 tons (21%)** of materials recycled, up from 19% in 2023.

## **Looking Ahead**

Goodwill remains committed to reducing waste, expanding recycling programs and exploring new eco-friendly initiatives for a greener tomorrow.



# Retail Round Up Provides a Hand Up to Neighbors in Need

Honoring the generosity of Goodwill Director Elizabeth Clark, the Elizabeth Clark Emergency Fund continues her legacy by assisting individuals and families each year with essential clothing, furniture and household items from Goodwill stores.

Since the late 1970s, Goodwill has provided crisis vouchers, evolving into today's fund, which distributes \$110,000–\$330,000 annually in gift cards to those facing hardship. In 2024 alone, \$211,000 was redeemed by individuals and families.

This vital program is made possible by Goodwill shoppers who round up their purchases to the next dollar, directly supporting their neighbors in need. Thanks to the dedication of Goodwill's retail sales associates, almost \$118,000 was raised in 2024!

Through community generosity and the ongoing support of Goodwill shoppers, the Elizabeth Clark Emergency Fund continues to help meet the needs of individuals and families in our communities.

## Doug Prospers through Entrepreneurship and Life

Goodwill met Doug through its Employability Rebranded program, which serves individuals reentering the community from incarceration. After experiencing hardships with addiction and the justice system, Doug made a life-changing decision to turn things around for his daughters.

Determined to rebuild, he came to Goodwill's Richland County vocational office with a vision—starting a transportation service to help others overcome the barriers he once faced. With Goodwill's support, he launched 419 RideShare in 2021, providing safe, affordable rides to his community.

Doug's commitment to giving back extends beyond his business. He joined the Goodwill-led Richland County Citizen Circle, assisted in mock interviews, spoke at workforce reentry events and now serves on the Third Street Family Clinic board.

Years later, 419 RideShare thrives on word-of-mouth referrals. Doug credits his success to an internal drive for


change and the support of those who believed in him. Goodwill proudly celebrates Doug's perseverance and generosity and is honored to witness his continued success.







Change in Net Assets


Net Assets Beginning (2023 audited)


